SEASON BADGE BYE-LAWS

- 1. The Stewards of the Hong Kong Jockey Club ("the Stewards") may issue an admission badge ("Season Badge") valid for the period hereinafter prescribed to a person who is not a Member of The Hong Kong Jockey Club ("the Club") in accordance with the subject to the provisions of these Bye-laws.
- 2. In these Bye-laws the expression "Holder" shall mean the individual to whom a Season Badge is issued.
- 3. a. The validity of Season Badge shall commence on the first race day of a racing season and expire at the conclusion of the last race day of a racing season. The Stewards may introduce at their discretion Half-year Season Badges sold during the course of a racing season.
 - b. A Season Badge shall be deemed invalidated by the Stewards if the same is so damaged or defaced as to make it impossible to identify the individual to whom it was issued.
- 4. Each Season Badge (including any replacement) remains the property of the Club. A SEASON BADGE IS NOT TRANSFERABLE AND MAY ONLY BE USED BY THE HOLDER. A Season Badge found in the possession of a person other than the Holder whilst on the premises of the Club shall be declared invalid. If a Season Badge is declared invalid and a request is made for it to be surrendered, the Holder shall comply with the request to surrender the Season Badge. The Club may repossess a Season Badge in the possession of a person other than the Holder on the premises of the Club and such person may be removed from the premises of the Club.
- 5. a. A person making an application for a Season Badge shall be proposed by a Member. A Member may propose such number of persons to purchase Season Badges as the Stewards may from time to time determine.
 - b. The application shall be made on such form as may be prescribed from time to time by the Stewards.
 - c. The application form, prescribed from time to time by the Stewards, shall be deemed part of these Bye-laws whereby the terms and/or conditions contained therein shall be enforceable as part of these Bye-laws.
- 6. The subscription price for a Season Badge shall be determined from time to time by the Stewards. Each application for a Season Badge shall have annexed to it the applicant's cheque drawn on a licensed bank in Hong Kong payable to "The Hong Kong Jockey Club" and crossed "A/c Payee Only", for the subscription price. The cheque will be cashed on receipt. If the cheque does not clear on first presentation, the application will be rejected. An unsuccessful applicant whose cheque has been cleared will have the subscription price returned as provided in the application form.
- 7. The Holder of a Season Badge may attend all race meetings at either racecourse during the season for which the Season Badge is issued.
- 8. a. The Holder of a Season Badge must enter the Members' Enclosure through the special entrances designated for them at the entrance to the Members' Stands.
 - b. The Holder of a Season Badge is not permitted to enter the Public Enclosures save as permitted under Bye-law 8ciii below or enter the Members' Enclosures via the Public Enclosures.
 - c. The Holder of a Season Badge is permitted to enter only the following areas:
 - i. Happy Valley Racecourse Members' Stands up to 2nd Floor when racing is at Happy Valley.
 - ii. Sha Tin Racecourse Members' Stand up to 2nd Floor when racing is at Sha Tin.
 - iii. For cross-betting, Sha Tin Racecourse Public Stand when racing is at Happy Valley, and Happy Valley Racecourse Members' Stands up to 2nd Floor when racing is at Sha Tin.

- d. The Stewards may, from time to time, alter the areas to which the Holder of a Season Badge may have access.
- e. The Holder of a Season Badge may use those of the premises of the Club which are provided by the Stewards for cross-betting and whether in common with Members of the Club or in areas exclusively set aside for the Holders of Season Badges.
- f. Unless in the company of a Member of the Club, the Holder of a Season Badge who is found on the premises of the Club other than those areas to which access is permitted pursuant to these Bye-laws may be ejected from the Racecourse on the direction of a Steward, the Chief Executive or an Official of the Club and in such event the Holder shall surrender the Season Badge on demand and the Stewards may cancel the Season Badge for all or, in their absolute discretion, some part of the remainder of the racing season and no part of the subscription price shall be refunded.
- 9. The Holder of a Season Badge must display his Season Badge prominently at all times when on the premises of the Club and on request by an employee or agent of the Club must hand it over for inspection.
- 10. If a Steward, the Chief Executive or an Official of the Club is satisfied that the Holder of a Season Badge is not complying with any of the provisions of these Bye-laws to the satisfaction of such Steward, the Chief Executive or an Official, such Steward, the Chief Executive or an Official may declare the Season Badge invalid and, if the Holder is on the premises of the Club, the Holder may be requested to leave the premises of the Club immediately. If the Holder refuses to do so, without prejudice to any other legal remedy, he may be removed from the premises of the Club on the order of a Steward, the Chief Executive or an Official.
- 11. It is the duty of the Holder to report the loss of his Season Badge to the Membership Services Department of the Club as soon as possible. The decision to issue a replacement for any Season Badge which has been reported by the Holder as damaged, stolen, lost or destroyed shall be in the absolute discretion of the Stewards who may impose such conditions upon the issue of a replacement as shall be thought fit. The Club shall impose such charge for the issue of a replacement badge as shall from time to time be determined by the Stewards.
- 12. a. If in the opinion of a Steward, the Chief Executive or an Official of the Club, the Holder of Season Badge whilst on the premises of the Club is guilty of causing any noise, uproar or disturbance or of ungentlemanly or improper conduct or of any other conduct, whatsoever, detrimental to the interests of the Club or of any Member such Holder may be requested immediately to leave the premises by a Steward, the Chief Executive or an Official, and if such Holder refuses to do so he may be removed from the premises at the order of a Steward, the Chief Executive or an Official authorised by the Stewards. The Steward, the Chief Executive or the Official concerned shall report the incident to the Stewards as soon as practicable and the Member who proposed such Holder will be informed of the incident by copies of the relevant correspondence and such copies will be kept on the proposing Member's personal file.
 - b. The Stewards may, in their absolute discretion, direct that the Season Badge of an Holder infringing this Bye-law shall be declared invalid for all or some part of the remainder of the racing season and no part of the subscription price shall be refunded.
- 13. If the Holder of a Season Badge infringes any of the Rules of the Club to which he is subject the Stewards may, in their absolute discretion, direct that the right to propose persons for Season Badges will be withdrawn for a definite or indefinite period from the proposing Member.
